The Chairman opened the meeting by welcoming all present.

1. Apologies for absence

Apologies were received from Janet Cole (East Anglian Labrador Retriever Club), one representative from the Labrador Retriever Club, and representatives from Cotswold & Wyevern Labrador Retriever Club.

2. <u>Minutes</u>

The minutes of the Annual General Meeting held on 11 April 2016 were circulated. The minutes were approved, having been proposed as being an accurate record by David Coode, Labrador Retriever Club, and seconded by Anne Johnson, Three Ridings Labrador Retriever Club.

3. <u>Matters arising</u>

It was confirmed that Fiona Braddon had received payment in respect of work carried out on the website.

4. Adoption of Accounts
